RESOLUTION NO. 1022-2022

DECLARING MUNICIPAL ORDINANCE NO. 2022-04 OF THE SANGGUNANG BAYAN OF SISON, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS POSITIONS IN THE ORGANIZATIONAL STRUCTURE OF THE MUNICIPAL GOVERNMENT OF SISON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Ordinance No. 2022-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2022-04 of the Sangguniang Bayan of Sison, Pangasinan, entitled "An Ordinance creating various positions in the organizational structure of the Municipal Government of Sison, Pangasinan" as within the conferred powers of the Sanggunian Bayan to enact;


