APPROVING RESOLUTION NO. 48, S-2022 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 3 FOR CY-2022 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P14,745,800.00 FROM THE REPROGRAMMING OF EXCISE TAX SHARE OF 2018 AND 2019, P1,500,000.00 FROM THE REPROGRAMMING OF PURCHASE OF LOT FOR THE EVACUATION/MULTI-PURPOSE HALL AT BRGY. COLISAO, P2,702,413.54 FROM THE REALIGNMENT OF VARIOUS FUNDS AND P190,000.00 FROM PHILIPPINE CHARITY SWEEPSTAKES OFFICE"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SP Resolution No. 48, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 3 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 03-S. 2022 dated September 9, 2022, to the Sangguniang Bayan for approval;

2. Said Supplemental AIP, which has an investment requirement of ₱19,138,213.54, covers the augmentation of funds for Personal Services (to include the granting of Performance – Based Bonus to qualified officials and employees of the LGU), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some offices of the LGU, and implementation of other development projects of the LGU;
3. The proposed projects to be funded from the Tobacco Excise Tax Share of the LGU (CYs 2018 and 2019) are based on RA No. 8240 and related Local Budget Memorandum of the Department of Budget and Management. Likewise, the development project proposed to be funded from the 20% Development Fund were based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and
4. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 4 for CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, S-2022 dated November 7, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 48, S-2022 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled “Approving the Supplemental Annual Investment Plan No. 3 for CY-2022 of the Local Government of San Fabian, Pangasinan in the amount of P14,745,800.00 from the reprogramming of Excise Tax Share of 2018 and 2019, P1,500,000.00 from the reprogramming of purchase of lot for the Evacuation/Multi-Purpose Hall at Brgy. Colisao, P2,702,413.54 from the realignment of various funds and P190,000.00 from Philippine Charity Sweepstakes Office”;




