**DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR
CALENDAR YEAR 2022 OF SAN FABIAN, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P19,138,213.54,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2022 involving total appropriations of Php19,138,213.54, which was enacted on November 7, 2022 through Appropriation Ordinance No. 4, S-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the implementation of projects funded by the share from tobacco excise tax shall be in accordance with the provisions of Local Budget Memorandum Number 83 and 84 dated November 22, 2021;

2. That the projects funded under the 20% of the National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects.";
3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
5. That the grant of Performance Based Bonus (PBB) for FY 2021 to all municipal officials and employees of the municipality shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Reporting Systems Memorandum Circular No. 2021-1 dated June 3, 2021.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Its Entirety the Supplemental Budget No. 4 for Calendar Year 2022 of San Fabian, Pangasinan;


