The Local Development Council of Burgos, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.4 CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 3, 2022 by the Municipal Development Council through Resolution No. 2022-05;
- Said SAIP covers fund augmentation for Personal Services and Maintenance and Other Operating of some municipal government offices, and the implementation of priority programs/projects of the LGU; and
