The Local Development Council of Sual, Pangasinan had identified items in their Revised Annual Investment Program (RAIP) No.2 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on June 30, 2022 by the Municipal Development Council through Resolution No. 4, Series of 2022;

- 2. The AIP was revised to integrate the proposed projects from the revised LDRRMPlan proposed to be funded from the unexpended LDRRMI Fund from CY 2021 which emanated from the LDRRM Council and endorsed to the Sangguniang Bayan through Resolution No.2, Series of 2022 dated June 29, 2022; and

This is in pursuant to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states: "The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP".
