**RESOLUTION NO. 1033-2022**

**APPROVING RESOLUTION NO. 2022-89 OF THE SANGGUNANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 3, FOR THE CALENDAR YEAR 2022 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2022-89 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Balungao, Pangasinan had identified items in their Supplemental Investment Program (SIP) No.3 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 9, 2022 by the Municipal Development Council through Resolution No. 2022-06;

2. The SAIP No.3 of the municipality covers fund augmentation for Personal Services (payment of Performance Based Bonus of LGU officials and employees), Maintenance and Other Operating Expenses and Capital Outlay of some offices of the Local Government Unit of Balungao;
3. Funding support for the implementation of the same in the amount of Php6,202,272.81 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2022 which was enacted by their Sangguniang thru Appropriation Ordinance No. 2022-04 on November 14, 2022; and
4. Likewise, SAIP No. 3 also includes the reprogrammed 20% development fund amounting to Php3,000,000.00 which was previously allocated for the Rehabilitation of the New Cemetery to the Construction of Sidewalk along Teodoro Bascos Street, Poblacion, Balungao, Pangasinan. The new project is based on DBM-DOF-DILG-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 "Revised Guidelines on the Appropriation and Utilization of the 20% of the Internal Revenue Allotment for Development Projects".

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2022-89 of the Sangguniang Bayan of **Balungao**, Pangasinan, entitled "Approving the Supplemental Annual Investment Program (Saip) No. 3, for the Calendar Year 2022 of the Municipality of Balungao, Pangasinan";
