**RESOLUTION NO. 1034-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR  
CALENDAR YEAR 2022 OF BALUNGAO, PANGASINAN  
INVOLVING A TOTAL APPROPRIATION OF P6,202,272.81,  
OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P6,202,272.81, which was enacted on November 14, 2022 through Appropriation Ordinance No. 2022-04;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the grant of Performance-Based Bonus for FY 2021 to all qualified officials and employees of the municipality shall be subject to the provisions of Inter-Agency Task Force (IATF) on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2021 - 1 dated June 3, 2021;
3. That the municipality failed to appropriate 5% Local Disaster Risk Reduction and Management Fund amounting to Php156,539.00. Said shall be appropriated in the next supplemental budget of the municipality pursuant to Section 324(d) of R.A. No. 7160 and Section 21 of R.A. No. 10121;
4. That the appropriation for Other Maintenance and Operating Expenses shall cover only other expenses not otherwise classified under any of the specific maintenance and other operating expense accounts, in accordance with the Revised Chart of Accounts for LGUs under COA Circular No. 2015-009 dated December 1, 2015;
5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated 09 March 2007; and
6. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Its Entirety the Supplemental Budget No. 3 for Calendar Year 2022 of Balungao, Pangasinan;




