**APPROVING RESOLUTION NO. 169-2022 OF THE SANGGUNANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL BUDGET NO. 03, CY 2022 INVOLVING AN AMOUNT OF EIGHT MILLION TWO HUNDRED THOUSAND PESOS (P8,200,000.00) FUNDED FROM UNDERESTIMATED INCOME FOR C.Y. 2022 FOR PURPOSES OF THE IMPLEMENTATION OF PROGRAMS AND PROJECTS IN VARIOUS OFFICES OF THE MUNICIPALITY OF ROSALES, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Rosales Pangasinan submitted its SB Resolution No. 169-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Plan No. 03 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 29, 2022 by the Municipal Development Council through MDC Resolution No. 1129 S. 2022;

2. The SIP No. 3 covers fund augmentation for Maintenance and Other Operating Expenses of various offices of the LGU and implementation of disaster risk reduction programs and development projects of the LGU Rosales;
3. Funding support for the implementation of the same in the amount of PhP8,200,000.00 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 04-2022 on December 2, 2022.




