The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Plan No. 03 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 29, 2022 by the Municipal Development Council through MDC Resolution No. 1129 S. 2022;

- The SIP No. 3 covers fund augmentation for Maintenance and Other Operating Expenses of various offices of the LGU and implementation of disaster risk reduction programs and development projects of the LGU Rosales;
- 3. Funding support for the implementation of the same in the amount of PhP8,200,000.00 is embodied in their proposed Supplemental Budget No. 3 for Calendar Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 04-2022 on December 2, 2022.
