RESOLUTION NO. 1037-2022

DECLARING MUNICIPAL ORDINANCE NO. 2022-017 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE FOR THE CONDUCT OF ANNUAL CHRISTMAS AND FIESTA FOOD BAZAAR AND IMPOSING FEES AND OTHER CHARGES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2022-017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 447 (a) (3) (i) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting pursuant to Sections 59 (c) of RA 7160;




