DECLARING MUNICIPAL ORDINANCE NO. 2024-13 OF THE SANGGUNANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SOME PROVISIONS OF MUNICIPAL ORDINANCE NO. 2017-105, AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2001-90 (AN ORDINANCE UPDATING THE COMPREHENSIVE LAND USE ZONING REGULATIONS OF THE MUNICIPALITY OF MANGALDAN AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF AND THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH)” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
