**APPROVING RESOLUTION NO. 2024-230 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “APPROVING THE CY 2024 REVISED ANNUAL INVESTMENT PROGRAM (RAIP) NO. 2 OF SUAL, PANGASINAN INCORPORATING SIX MILLION PESOS (P6,000,000.00) UNDER THE LDRRMF-DISASTER RESPONSE PROGRAM”**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2024-230 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sual, Pangasinan has identified items in their Revised Annual Investment Program No. 2 for CY 2024. This was endorsed to the Sangguniang Bayan on November 22, 2024 through MDC Resolution No. 9, Series of 2024 and was favorably acted upon by the Sangguniang Bayan on December 16, 2024 through SB Resolution No. 2024-230;
2. The AIP of LGU Sual was revised to integrate the proposed disaster risk reduction and management program to be funded from the unexpended balances of the LGU’s LDRRM Fund CY 2023 amounting to PhP6,000,000.00. This has emanated from the MDRRM Council through Resolution 3, Series of 2024 dated November 21, 2024. This is in

pursuance to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states:

“The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP”; and

3. These disaster risk reduction and management program is based on the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund).

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sual, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-230 of the Sangguniang Bayan of Sual, Pangasinan, entitled “Approving the CY 2024 Revised Annual Investment Program (RAIP) No. 2 of Sual, Pangasinan incorporating Six Million Pesos (P6,000,000.00) under the LDRRMF-Disaster Response Program”;
