RESOLUTION NO. 284-2025

DECLARING MUNICIPAL ORDINANCE NO. 57, S-2024 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE OPERATION OF PIGGERY AND POULTRY FARMS IN THE MUNICIPALITY OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 57, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17(b)(i) and 447(a)(1)(2)(ix) of Republic Act No. 7160;

WHEREAS, subject ordinance shall take affect after compliance with the requirement of publication pursuant to Section 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 57, S-2024 of the Sangguniang Bayan of Aguilar, Pangasinan, entitled "An Ordinance regulating the operation of piggery and poultry farms in the Municipality of Aguilar, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
