PROVINCIAL RESOLUTION NO. 286-2025

**INVITING THE HONORABLE GOVERNOR, RAMON V. GUICO III,
TO DELIVER THE STATE OF THE PROVINCE ADDRESS BEFORE
THE 11TH SANGGUNIANG PANLALAWIGAN ON ITS APRIL 5,
2025 SPECIAL SESSION**

WHEREAS, Section 465 (iii) of RA 7160, otherwise known as the Local Government Code of 1991, mandates that the provincial governor shall “present the program of government and propose policies and programs for the consideration of the Sangguniang Panlalawigan every calendar year...”;

WHEREAS, it is imperative that the 11th Sangguniang Panlalawigan be apprised of Honorable Governor Ramon V. Guico III’s policies, priority development plans, and programs for the Provincial Government to engender a continuous atmosphere of effective and closely coordinated working relationship between the Province’s executive and legislative bodies;

WHEREAS, optimum coordination between the executive and legislative bodies of the Provincial Government could best be achieved by enabling the honorable Provincial Governor to personally inform the 11th Sangguniang Panlalawigan of his defined goals and priorities;

WHEREAS, the 11th Sangguniang Panlalawigan would be honored to listen to the Governor’s Report of Honorable Ramon V. Guico III in one of its Special Sessions preferably on April 5, 2025, so it could be appropriately documented into the annals of history of the legislative body of the Province;

NOW, THEREFORE, on unanimous motion, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to invite, as he is hereby invited, the Honorable Governor, Ramon V. Guico III, to deliver the State of the Province Address before the 11th Sangguniang Panlalawigan on its April 5, 2025 Special Session;
