**APPROVING RESOLUTION NO. 468, S-2025 OF THE SANGGUNANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 FOR CY 2025 OF BASISTA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 468, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Coordinator have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2025 and endorsed the same through MDC Resolution No. 1, Series of 2025 dated January 16, 2025 and approved the Sangguniang Bayan on January 20, 2025. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱2,900,000.00, covers the implementation of various development projects of the LGU. The projects proposed to be funded from the realigned 20% Development Fund in CY 2024 in the amount of ₱2,900,000.00 conform with the Joint DBM-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation

and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects); and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, FY 2025, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2025 dated January 20, 2025 and approved by the Local Chief Executive on February 3, 2025.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Basista, Pangasinan;


