RESOLUTION NO. 310-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 7 FOR CALENDAR YEAR 2024 OF STA. BARBARA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P4,376,049.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Supplemental Budget No. 7 for Calendar Year 2024 involving a total appropriations of P4,376,049.00, which was enacted on December 26, 2024 through Appropriation Ordinance No. 2024-056;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the appropriation for the 5% calamity fund's which is appropriated in compliance with the committee's recommendation shall be disbursed in accordance with R.A. No. 10121, known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund; and
3. That the grant of Gratuity Pay shall be in accordance with Budget Circular 2024-08 dated December 20, 2024 in consonance with Administrative Order 28, S. 2024.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


