**APPROVING RESOLUTION NO. 154, S-2024 OF THE SANGGUNANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “APPROVING THE 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 AND OTHER ACTIVITIES RELATED TO THE SUPPLEMENTAL BUDGET NO. 4 FUNDS IN THE AMOUNT OF SEVEN MILLION EIGHT HUNDRED FORTY FOUR THOUSAND ONE HUNDRED TEN PESOS AND 53/100 CENTAVOS (P7,844,110.53) OF THE MUNICIPALITY OF VILLASIS, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Resolution No. 154, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Villasis, Pangasinan has identified items in their Supplemental Annual Investment Program No. 4. This was endorsed to the Sangguniang Bayan for approval on December 3, 2024 by the Municipal Development Council-Executive Committee through Resolution No. 06-2024;

2. The SAIP covers fund augmentation for the MOOE (provide financial assistance for Senior Citizen Affair and conduct of training for manpower development) and implementation of infrastructure projects of the LGU; and
3. Funding support for the full implementation of the same in the amount of Php 7,844,110.53 as embodied in their proposed Supplemental Budget No.4 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 05 on December 9, 2024 and approved by the Municipal Mayor on December 20, 2024.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Villasis, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 154, S-2024 of the Sangguniang Bayan of Villasis, Pangasinan, entitled “Approving the 2024 Supplemental Annual Investment Program No. 04 and other activities related to the Supplemental Budget No. 4 Funds in the amount of Seven Million Eight Hundred Forty Four Thousand One Hundred Ten Pesos and 53/100 Centavos (P7,844,110.53) of the Municipality of Villasis, Pangasinan”;
