RESOLUTION NO. 322-2025

APPROVING RESOLUTION NO. 2025-654 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 1, FOR THE CALENDAR YEAR 2025 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2025-654 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Balungao, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 1 for CY 2025. This was endorsed to the Sangguniang Bayan on February 3, 2025 through MDC Resolution No.2025-01 and was favorably acted upon by the Sangguniang Bayan on February 6, 2025 through SB Resolution No. 2025-654;
2. The SAIP No. 1 of the municipality covers fund augmentation for Personal Services (Salary increase of employees from 4th class to 1st class municipality and implementation of Second Tranche of Modified Salary Schedule for government employees) and the implementation of disaster risk reduction programs and projects of the municipality and

implementation of programs/projects in support to the tobacco growing farmers in the LGU;

The programs and projects to be funded from the municipality's share from the FY 2022 Burley and Native Tobacco Excise Tax Collection are based on Local Budget Memorandum No. 91 dated August 29, 2024; and

3. Funding support for the proposed SAIP No.1, with a total investment requirement of Php27,114,901.00 is embodied in the municipality's Supplemental Budget No. 01, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2025-1 on February 6, 2025 and approved by the municipal mayor on February 10, 2025.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Balungao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

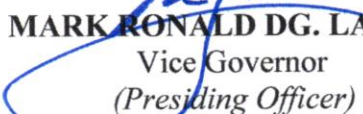
