RESOLUTION NO. 326-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 6 FOR FISCAL YEAR 2024 OF SAN NICOLAS, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P1,359,873.21, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Supplemental Budget No. 6 for Calendar Year 2024 involving total appropriations of Php1,359,873.21 which was enacted on December 20, 2024 through Appropriation Ordinance No. 7, S-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That all procurement to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
- 2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2024 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 2007;

- 3. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R. A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
- 4. That the reversion of saving shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings).

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 6 for Calendar Year 2024 of San Nicolas, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of San Nicolas, Pangasinan, for its information and guidance.
