APPROVING MUNICIPAL RESOLUTION NO. 323, S-2024 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 7 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN”

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Resolution No. 323, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Nicolas, Pangasinan has identified items in their Supplemental Investment Program No. 7 for CY 2024. This was endorsed by the Municipal Development Council to the Sangguniang Bayan on December 13, 2024 through MDC Executive Committee Resolution No. 10, CY-2024;
2. The SAIP No. 7 of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive (SRI) to qualified municipal government officials and employees) of the LGU San Nicolas;

3. Funding support for the proposed SAIP, with a total investment requirement of Php885,234.20 is embodied in the municipality's Supplemental Budget No. 07-CY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 8, Series of 2024 on December 20, 2024.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


