RESOLUTION NO. 336-2025

APPROVING MUNICIPAL RESOLUTION NO. 2024-220 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 FOR CALENDAR YEAR 2024 OF THE MUNICIPALITY OF ALCALA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Resolution No. 2024-220 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Alcala, Pangasinan has identified items in their 3rd Supplemental Annual Investment Program. This was endorsed to the Sangguniang Bayan for approval on September 30, 2024 by the Municipal Development Council thru Resolution No. 2024-03;
2. The SAIP covers programs and projects in support to tobacco-growing farmers and disaster risk reduction programs in the LGU with an investment requirement of Php 62,918,550.00 to be funded from the shares of the LGU from the tobacco excise tax and Purchase of Fire Fighting and Office Equipment with an investment requirement of Php 413,887.63 to be funded from the 20% LGU shares from the Fire Code revenues;

3. The programs and projects to be funded from the share of the municipality from the FY 2022 Burley and Native Tobacco Excise Tax Collection are based on Local Budget Memorandum No. 91, dated August 29, 2024; and
4. Funding support for the full implementation of the said SIP with the total amount of PhP 63,332,437.63 is embodied in their proposed Supplemental Budget No. 3 for CY 2024 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2024-03 on October 28, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Alcala, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-220 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “Approving the Supplemental Annual Investment Program No. 03 for Calendar Year 2024 of the Municipality of Alcala, Pangasinan”;
