RESOLUTION NO. 337-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2024 OF ALCALA, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P63,332,437.63, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P63,332,437.63 was enacted on October 28, 2024 through Appropriation Ordinance No. 2024-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;

3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017 dated March 8, 2007;
4. That the utilization of appropriations from shares of the LGU from the FY 2022 Collections of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act (RA) No. 7171, and Burley and Native Tobacco Excise Tax pursuant to RA No. 8240, as amended by RA No. 10351 shall be subject to the provisions of Local Budget Memorandum No. 91 dated August 29, 2024; and
5. That the disbursement of Share of Fire Code Fees shall be in accordance with DBM-DILG-DOF Joint Memorandum Circular No.1, S. 2023 dated April 17, 2023.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 3 for Calendar Year 2024 of Alcala, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Alcala, Pangasinan, for its information and guidance.
