RESOLUTION NO. 338-2025

APPROVING RESOLUTION NO. 2025-004 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (SAIP) NO. 1 FOR CALENDAR YEAR 2025 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO TWENTY-TWO MILLION EIGHT HUNDRED EIGHTY-SEVEN THOUSAND FIFTY-TWO PESOS (P22,887,052.00)”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2025-004 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their Supplemental Annual Investment Program No. 5. This was endorsed to the Sangguniang Bayan for approval on October 8, 2024 by the Municipal Development Council thru Resolution No. 2024-05;
2. The SAIP covers fund augmentation for Capital Outlay and MOOE of priority projects in support to tobacco growing farmers of the LGU with a total investment requirement of Php 22,887,052.00 to be funded from the shares of the LGU from the tobacco excise tax and disaster risk reduction programs and projects of the municipality;

3. The programs and projects proposed to be funded from the share of the LGU from the tobacco excise tax are based on Local Budget Memorandum No. 91, dated August 29, 2024; and
4. Funding support for the full implementation of the same is embodied in their proposed Supplemental Budget No. 1 for CY 2025 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2025-001 on January 20, 2025.




