**RESOLUTION NO. 339-2025**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2025 OF LAOAC, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P22,887,052.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2025 involving total appropriations of P22,887,052.00 was enacted on January 20, 2025 through Appropriation Ordinance No. 2025-001;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR, as amended by administrative Order No. 47 dated April 12, 1993;
2. That the utilization of appropriations from FY 2022 shares of the Municipality from the Burley and Native Tobacco Excise Tax Collections under R.A. No. 8240 shall be subject to the provisions of Local Budget Memorandum No. 91 dated August 29, 2024;

3. That all procurements to be undertaken shall be in accordance with the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2025 Annual Investment Program of the municipality and its supplements thereto, formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007; and
5. That the items funded out of the Local Disaster Risk Reduction & Management Fund shall be in accordance with R.A. No. 10121, known as the Philippine Disaster Risk Reduction & Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation & Utilization of the Local Disaster Risk Reduction & Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the Municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 1 for Calendar Year 2025 of Laoac, Pangasinan;
