RESOLUTION NO. 358-2025

APPROVING RESOLUTION NO. 136, S-2024 OF THE SANGGUNIAN BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 4 OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2024”

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 136, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality’s Supplemental Annual Investment Program No. 4 for CY 2024. This was endorsed by the Council, through MDC Executive Committee Resolution No. 6, Series of 2024 dated December 12, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of P4,667,940.76, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives for municipal officials and employees) and Maintenance and Other Operating Expenses (MOOE) of some offices of the LGU, and implementation of LDRRM program and GAD projects/activities of the municipality. The project proposed to be funded from the 5% LDRRM

Fund conforms with Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 04, FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 13, Series of 2024 dated December 13, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


