PROVINCIAL RESOLUTION NO. 377-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SOCIAL SECURITY SYSTEM (SSS) FOR THE USE OF AN OFFICE SPACE OWNED BY THE PROVINCE OF PANGASINAN LOCATED AT THE GROUND FLOOR OF THE PANGASINAN EMPLOYMENT SERVICES OFFICE (PESO) BUILDING, CAPITOL COMPOUND, LINGAYEN, PANGASINAN

WHEREAS, the Social Security System (SSS) is one of the frontline services of the national government which is mandated to establish, develop, promote and perfect a sound and viable tax-exempt social security system suitable to the needs of the people throughout the Philippines;

WHEREAS, the SSS also provides protection to members and their families against the hazards of disability, sickness, maternity, old age, death and other contingencies resulting in loss of income or financial burden;

WHEREAS, the Provincial Government of Pangasinan, acknowledging the services rendered by SSS to hundreds of clients every working day coming from the different parts of the Province, has offered to set aside an approximately One Hundred Six (106) square meters floor area of office space located at the ground floor of the Pangasinan Employment Services Office (PESO) Building, Alvear Street, Lingayen, Pangasinan, to be utilized by SSS free of charge;

WHEREAS, the term of the Memorandum of Agreement shall be for a period of five (5) years to commence upon the signing of the Parties;

WHEREAS, the terms and conditions stipulated in the Memorandum of Agreement are beneficial to both Parties;

WHEREAS, this Agreement will serve as a vehicle for collaboration efforts between the Provincial Government of Pangasinan and the SSS to further boost the social security programs and services in the Province;

WHEREAS, Section 465(vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Social Security System, represented by Vice President Vilma P. Agapito, Luzon Central I Division Head, and Mr. Jose Alvin M. Altre, SSS Alaminos Branch Head;

NOW, THEREFORE, on motion of SP Member Salvador S. Perez, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with the Social Security System (SSS) for the use of an office space owned by the Province of Pangasinan located at the ground floor of the Pangasinan Employment Services Office (PESO) Building, Capitol Compound, Lingayen, Pangasinan;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan; and Vice President Vilma P. Agapito, Luzon Central I Division Head, and Mr. Jose Alvin M. Altre, SSS Alaminos Branch Head, both of Social Security System, for their information and guidance.
