DECLARING MUNICIPAL ORDINANCE NO. 2022-03 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE ASSISTANT II (PROPERTY CUSTODIAN), SALARY GRADE 8, IN THE EXECUTIVE DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF AGNO, PANGASINAN, DETERMINING ITS DUTIES AND RESPONSIBILITIES, EFFECTIVE UPON APPROVAL" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, the Sangguniang Bayan shall enact a supplemental budget to fund the newly-created position as by the Local Finance Committee stated in its opinion dated June 16, 2022;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Carolyn D. Sison, duly seconded, it was –
