RESOLUTION NO. 617-2022

APPROVING RESOLUTION NO. 60, S-2022 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2022 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 60-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of Binmaley, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 1, Series of 2022 dated June 13, 2022, to the Sangguniang Bayan for approval.
- 2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱8,662,844.65, covers augmentation of funds for Personal Services (PS) and Maintenance and Other Operating Expenses (MOOE) of some offices of LGU Binmaley.

3. Funding for the Supplemental AIP will be sourced from the savings of the LGU and reversion of some funds as embodied in their Supplemental Budget No. 1 for FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2022 dated June 14, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Carolyn D. Sison, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 60-2022 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled "Approving the Supplemental Investment Program No. 1 for CY 2022 of the Municipal Government of Binmaley, Pangasinan";
