DECLARING ORDINANCE NO. 2022-043 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE OPERATIONALIZING FREEDOM OF INFORMATION (FOI) IN THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN AND PROVIDING GUIDELINES THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Municipal Ordinance No. 2022-043 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Article III, Section 7 of the 1987 Constitution of the Philippines, Executive Order No. 02, S. 2016 issued by President Rodrigo Duterte and Section 447 (a) (5) (x) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sanguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of RA 7160;
