DECLARING ORDINANCE NO. 2022-045 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR A MENTAL HEALTH PROGRAM IN THE MUNICIPALITY OF STA. BARBARA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Municipal Ordinance No. 2022-045 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with R.A. No. 11036, entitled "An Act Establishing a National Mental Health Policy for the Purpose of Enhancing the Delivery of Integrated Mental Health Services, Promoting and Protecting the Rights of Persons Utilizing Psychiatric, Neurologic and Psychosocial Health Services, Appropriating Funds Therefor and For Other Purposes" and Section 16 of R. A. No. 7160;

WHEREAS, the Sangguniang Bayan shall take into consideration the observations of the Provincial Legal Officer stated in her opinion dated June 21, 2022 on Section XVIII of the subject ordinance;
