RESOLUTION NO. 626-2022

DECLARING MUNICIPAL ORDINANCE NO. 01-04182022 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE HONORING AND GRANTING CASH INCENTIVES TO NONAGENARIANS AND CENTENARIANS OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 01-04182022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010 and Sections 17 (b) (2) and 447 (a) (5) (xvi) of R. A. No. 7160, Republic Act No. 10868, otherwise known as “An Act Honoring and Granting Additional Benefits and Privileges to Filipino Centenarians, and for Other Purposes and Article XV, Section 4 of the 1987 Philippine Constitution;


