DECLARING MUNICIPAL ORDINANCE NO. 158-053122 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION III (8) OF MUNICIPAL ORDINANCE NO. 144-141021 ENTITLED "MUNICIPAL ORDINANCE CREATING TWO (2) DEPARTMENT AND NEW POSITIONS IN THE VARIOUS OFFICES, ABOLITION OF POSITIONS AND TRANSFERRING OF CERTAIN PLANTILLA POSITIONS IN THE MUNICIPALITY OF VILLASIS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


