DECLARING **ORDINANCE** S-2022 OF 2, SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN. ENTITLED "AN ORDINANCE **IMPOSING** FARE INCREASE FOR MOTORIZED TRICYCLES PLYING THEIR ROUTE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ASINGAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 2, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (3) (vi) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) R.A. 7160;
