RESOLUTION NO. 634-2022

APPROVING RESOLUTION NO. 159, S-2022 OF THE SANGGUNANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 1 WITH THE CY 2022 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 1 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 159-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of Asingan, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program (SAIP) No. 1 and endorsed thru MDC Resolution No. 1, S-2022 to the Sangguniang Bayan for approval on June 1, 2022. This is in pursuance to Sections 106, 109, 114 of the Local Government Code of 1991;

2. The Supplemental Annual Investment Program No. 1 with an investment requirement amounting to Php18,060,349.82 covers fund augmentation for the personal services, maintenance and other operating expenses and capital outlay of various offices and implementation of development programs of the LGU.
3. The Sangguniang Bayan enacted Supplemental Budget No. 1 through Appropriation Ordinance No. 1, S-2022 dated June 6, 2022 to support the implementation of the Supplemental Annual Investment Program No. 1 of the municipality.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Carolyn D. Sison, duly seconded, it was—


