DECLARING MUNICIPAL ORDINANCE NO. 2022-03 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE INVESTMENTS AND INCENTIVES CODE OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2022-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with RA 7042 (Foreign Investment Act of 1991), RA 7844 (Export Development Act of 1994), RA 7916 (Special Economic Zone Act of 1995) and Sections 16 & 109 (a) (1) (2) (3) (4) (5) (6), 192 and 447 (a) (2) (ii) (xii) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) R.A. 7160;
