RESOLUTION NO. 642-2022

APPROVING MUNICIPAL RESOLUTION NO. 140, S-2022 OF THE SANGGUNANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF SAN NICOLAS, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its SB Resolution No. 140-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of San Nicolas, Pangasinan has identified project to be funded by Local Government Support Fund-Financial Assistance to LGUs (LGSF-FA to LGUs) and included the same in the municipality's Supplemental Annual Investment Program. This was endorsed to the SB through MDC Resolution No. 01, CY 2022 dated May 25, 2022. This is in consonance to Sections 106, 109, 114 of the Local Government Code of 1991; and

The identified project is in accordance with Local Budget Circular No. 142 dated January 24, 2022 "Guidelines on the Release and Utilization of the Local Government Support Fund-Other Financial Assistance to Local Government Units and Support for Capital Outlays and Social Programs Under the FY 2022 General Appropriations Act, Republic Act No. 11639".


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Nicolas, Pangasinan;


