RESOLUTION NO. 643-2022

DECLARING ORDINANCE NO. 22-02 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING PART OF SECTION 3 OF ORDINANCE NO. 21-04 ENTITLED "ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN IN THE AMOUNT OF TWO HUNDRED FORTY-ONE MILLION PESOS (P241,000,000.00) TO FUND THE VARIOUS PROJECTS LISTED HEREIN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Ordinance No. 22-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Coordinator have conducted initial review and study on said municipal ordinance and found out that the power of the legislative body to enact and approve ordinances or resolutions carries with the power to amend, revoke, modify or repeal the same; however, since location of the specific project was amended through this ordinance, it is respectfully recommended that said changes shall be incorporated in the Supplemental Investment Program to be endorsed by the Municipal Development Council and approved by the Sanggunian;


