**PROVINCIAL RESOLUTION NO. 644-2022**

**CONFIRMING THE AUTHORITY OF THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ACCEPT THE PROJECT PROPOSAL FOR THE IMPLEMENTATION OF THE PANGASINAN EAST WEST EXPRESSWAY (PEWEx)**

**WHEREAS**, a good road network will play an important role in the economic growth and progress of a province;

**WHEREAS**, the new administration envisions the implementation of a proposed expressway project that would connect and integrate to the existing expressway at Tarlac-Pangasinan-La Union Expressway (TPLEX) to Alaminos City, Pangasinan, traversing the eastern and western boundaries of the Province;

**WHEREAS**, the proposed expressway project once realized will surely open-up areas for development in terms of better accessibility for people and goods, a boon to tourism, agriculture and local industry, and it will also help in the decongestion of traffic and the generation of more jobs in the Province, among others;

**WHEREAS**, a group of Indonesian and Filipino companies and their affiliates named SAHI-DMCU Consortium, through a letter to the Provincial Governor dated July 11, 2022, has signified its intention to undertake the implementation of the Pangasinan East West Expressway;

**WHEREAS**, during the Inaugural Session of the Sangguniang Panlalawigan held on July 11, 2022, the project proponent has formally turned over the proposal for the implementation of the Pangasinan East and West Expressway to the Provincial Government of Pangasinan with the presence of the Provincial Governor, Ramon V. **NOW, THEREFORE**, on motion of SP Member Salvador S. Perez, Jr., duly seconded, it was –


