PROVINCIAL RESOLUTION NO. 645-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I (DOH CHD I) FOR THE GRANT OF ONE COVID-19 ALLOWANCE (OCA) FOR PUBLIC HEALTH CARE WORKERS AND NON-HEALTH CARE WORKERS IN THE PROVINCE OF PANGASINAN

WHEREAS, RA No. 11639, otherwise known as the General Appropriations Act (GAA) for FY 2022, provides the basis for funds release on the grant of COVID-19 benefits for public and private health care workers and non-health care workers, regardless of employment status, who are involved in COVID-19 response in all health facilities including military hospitals, government-owned and controlled corporations, state university hospitals and private-licensed health facilities;

WHEREAS, Section 14 of the FY 2022 GAA Special Provision provides for the allocation of funds for COVID-19 benefits that shall be based on risk exposure of the health care workers and non-health care workers;

WHEREAS, Department of Health (DOH) Administrative Order No. 2022-0001 dated January 14, 2022, or the Guidelines for COVID-19 Risk Exposure Classification of Health Care Workers, sets the parameters for determining the risk exposure of personnel in COVID-19 response-involved health facilities;

WHEREAS, for the effective implementation of Joint Circular No. 2022-0001, dated February 10, 2022, of the Department of Budget and Management (DBM) and DOH, a Memorandum of Agreement shall be entered into and signed between the Department of Health and the Local Government Units for the transfer of funds for the One COVID-19 Allowance;

WHEREAS, the Province of Pangasinan is qualified to receive the One COVID-19 Allowance for the eligible health care workers and non-health care workers of the Provincial Health Office, Provincial Hospital Management Services Office and the 14 government hospitals of the Province from July to December 2022;

WHEREAS, the proposed agreement between the Province of Pangasinan and DOH-CHD I is executed to set forth the roles and responsibilities of the parties with respect to the implementation on the grant of the One COVID-19 Allowance;


WHEREAS, in regard to the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Department of Health Center for Health Development-I (DOH CHD I), represented by Dr. Paula Paz M. Sydiongco, Regional Director;

WHEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr. and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –


