## PROVINCIAL RESOLUTION NO. 646-2022

REQUESTING GOVERNOR RAMON V. GUICO III TO DIRECT THE PROVINCIAL HEALTH OFFICER TO MEET WITH REPRESENTATIVES FROM THE OFFICES OF CONGRESSMAN CHRISTOPHER DE VENECIA, MAYOR MARLYN E. AGBAYANI AND REPRESENTATIVES OF THE DEPARTMENT OF HEALTH TO IDENTIFY OPTIONS TO IMMEDIATELY OPERATE THE NEWLY CONSTRUCTED HEALTHCARE FACILITY IN BARANGAYS **INMALOG** SUR/LIPIT, SAN FABIAN, PANGASINAN AND TO REPORT HER FINDINGS TO THE SANGGUNIANG PANLALAWIGAN WITHIN FORTY-FIVE (45) DAYS SO MEASURES CAN BE DULY ADOPTED FOR THAT **PURPOSE** 

WHEREAS, the Office of the Honorable Christopher De Venecia, Congressman of the Fourth District of Pangasinan, has recently pursued the funding, construction, and completion of a new healthcare facility building in Barangay Inmalog Sur, San Fabian;

WHEREAS, the members of the Sangguniang Panlalawigan (SP) of Pangasinan are of the sense that the healthcare facility in Barangay Inmalog Sur will go a long way in ensuring the timely and efficient delivery of much needed health services to the people of San Fabian, especially those residing in the "Upland" barangays of San Fabian owing to their location, terrain and distance and where there is no available regular public transportation to the medical facilities at the town proper of San Fabian and Dagupan City;

WHEREAS, the health services that the Inmalog/Lipit facility are now all the more necessary and critical with the increasing incidence rate of Covid-19 cases and the expected surge in Dengue cases with the onset of the rainy season and start of a new school year;

WHEREAS, the members of the SP have been informed there is presently inadequate funding available from the national government and the municipality of San Fabian to procure hospital equipment and hire personnel for said hospital facility so it can commence operation sooner rather than later;

WHEREAS, the members of the SP share the view that, in light of the pressing need for the Inmalog Sur/Lipit healthcare facility to start operating as soon as possible notwithstanding the lack of available funds from the both the national government and the municipality of San Fabian, it is appropriate and desirable for the provincial government of Pangasinan to step in and explore options of how it can arrange for technical assistance or appropriate funds toward this end;

**NOW THEREFORE**, in view of the foregoing premises, on motion of SP Members Jerry Agerico B. Rosario and Marinor B. de Guzman, duly seconded, it was

**RESOLVED**, as it is hereby resolved respectfully request Governor Ramon V. Guico III to direct the Provincial Health Officer to meet with representatives from the Department of Health, offices of Congressman Christopher De Venecia and Mayor Marlyn Agbayani to identify options and areas of cooperation to immediately operate the newly constructed district hospital in Barangay Inmalog Sur/Lipit, San Fabian, Pangasinan and to report her findings to the SP within forty-five (45) days so measures can be duly adopted for that purpose; and

**RESOLVED FURTHER**, that copies of this resolution be transmitted to Congressman De Venecia and Mayor Agbayani, for their information and appropriate response.
