**RECALLING PROVINCIAL RESOLUTION NO. 505-2016 OF THE SANGGUNIANG PANLALAWIGAN AND LIFTING THE *PERSONA NON GRATA* STATUS OF DR. DEXTER R. BUTED, PRESIDENT OF THE PANGASINAN STATE UNIVERSITY, IN THE PROVINCE OF PANGASINAN"**

**WHEREAS**, on October 17, 2016, Provincial Resolution No. 505-2016 of the Sangguniang Panlalawigan, entitled "Declaring Dr. Dexter R. Buted, President of the Pangasinan State University, as *Persona Non Grata* in the Province of Pangasinan", was approved by the 9<sup>th</sup> Sangguniang Panlalawigan;
