PROVINCIAL RESOLUTION NO. 649-2022

URGING ALL LOCAL GOVERNMENT UNITS OF THE PROVINCE OF PANGASINAN TO PROVIDE NECESSARY ASSISTANCE TO ALL PUBLIC AND PRIVATE SCHOOLS IN THEIR RESPECTIVE AREAS OF JURISDICTION IN LINE WITH THE UPSURGE OF COVID-19 AND DENGUE CASES AND THE OPENING OF SCHOOL CLASSES IN THE COUNTRY

WHEREAS, COVID-19 infections are surging again in other countries including the Philippines due to the rapid spread of highly contagious Omicron variant and subvariant,

WHEREAS, some regions all over the country are also experiencing an increase on the average number of dengue cases for the past weeks;

WHEREAS, the Department of Education has already set the opening of classes for SY 2022-2023 by August 22, 2022;

WHEREAS, there is a need to ascertain the safety and protection of the people more particularly the learners, mentors and teachers in the occurrence of calamities or any emergency situation in the Province;

WHEREAS, the Department of Education is an active partner of the local government units in the promotion of its worthwhile plans and programs;

WHEREAS, the schools and teachers cannot fully implement their programs due to financial and other constraints but with the proper sourcing and help from the local government units, they can eventually achieve their goals;

NOW, THEREFORE, on motion of SP Member Noel C. Bince, duly seconded, it was –


