**PROVINCIAL RESOLUTION NO. 650-2022**

**URGING ALL LOCAL GOVERNMENT UNITS OF THE PROVINCE OF PANGASINAN TO FURTHER INTENSIFY AND CONTINUE WITH THEIR CAMPAIGN FOR COVID-19 VACCINATION IN THEIR RESPECTIVE AREAS OF JURISDICTION**

**WHEREAS**, the Local Government Code mandates local government units to exercise local autonomy and to ensure the general welfare of the people particularly in the promotion of their health and safety;

**WHEREAS**, local government units play vital roles in addressing and managing the health crisis and in ensuring the implementation of COVID-19 vaccination program which is proven to be effective to protect the people;

**WHEREAS**, the highly transmissible Omicron variant and subvariant of COVID-19 is again driving a surge of infections globally;

**WHEREAS**, there is a need to facilitate an intensified and continuous vaccination program in order to protect the people from COVID-19 infections;

**WHEREAS**, there is also a need to support the booster campaign rollout in order to safely resume face-to-face classes and fully reopen the economy;

**WHEREAS**, local government units are urged to utilize all available resources to convince their constituencies to be vaccinated and to receive booster shots for their protection and in order to minimize the spread of COVID-19 in their respective areas of jurisdiction;

**WHEREAS**, the Sangguniang Panlalawigan is seeking the help of local government units to protect the people against the dreaded disease by further intensifying their vaccination program and eventually put an end to the pandemic;


