PROVINCIAL RESOLUTION NO. 654-2022

INVITING THE MANAGEMENT OF CENPELCO, PANELCO I, PANELCO III, DECORP AND LUELCO TO A QUESTION HOUR OF THE SANGGUNANG PANLALAWIGAN OF PANGASINAN TO SHED LIGHT ON THE MATTER OF ITS POWER RATE INCREASE IMPLEMENTATION AND OTHER CONCERNS

WHEREAS, it is the earnest desire of the Sangguniang Panlalawigan to assist their constituents in their economic plight and financial woes particularly on utility bills and services;

WHEREAS, the sudden increased power rate implementation by CENPELCO, PANELCO I, PANELCO III, DECORP and LUELCO has hurt most the hard-up consumers of the said electric cooperatives who will bear the brunt of the new hike;

WHEREAS, the Sangguniang Panlalawigan would like to know if consultations were made by the electric cooperatives in the implementation of its power rate increase;

WHEREAS, the Sangguniang Panlalawigan would like to know also if the electricity bill of customers of CENPELCO, PANELCO I, PANELCO III, DECORP and LUELCO has increased due to a hike in the cost of electricity generation charges;

WHEREAS, the Sangguniang Panlalawigan is likewise interested on the matter of how they arrived at the increase of their power rate charges;

WHEREAS, the power rate hike of CENPELCO, PANELCO I, PANELCO III, DECORP and LUELCO has caused some groups to air their dismay at the sudden increase in their monthly electric bills;

WHEREAS, the presence of the electric cooperatives would go a long way to help the Sangguniang Panlalawigan in the enactment of legislative measures in order to enhance public utility services;
