PROVINCIAL RESOLUTION NO. 656-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ACCEPT THE DONATION OF A SIMPLIFIED FACILITY FROM ONE DOCUMENT CORPORATION

WHEREAS, the One Document Corporation is a company which focuses to uplift the healthcare system that accelerates progress, efficiency and economic growth through information technology;

WHEREAS, the One Document Corporation signified its intention to support the vision of the Provincial Government of Pangasinan of having a consolidated healthcare information record of its constituents;

WHEREAS, the One Document Corporation intends to donate a Simplified Facility that will enhance the healthcare system approach of the fourteen (14) hospitals in Pangasinan on relevant areas, namely: Consolidated Patient Corporation and the Inventory and Control Management;


