PROVINCIAL RESOLUTION NO. 660-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH CLEAN LEAF INTERNATIONAL CORPORATION FOR THE IMPLEMENTATION OF HEALTHCARE WASTES MANAGEMENT OF THE FOURTEEN (14) PROVINCIAL GOVERNMENT HOSPITALS OF PANGASINAN

WHEREAS, RA No. 7160, otherwise known as the Local Government Code of 1991, has vested upon local government units, the authority to prescribe regulations aimed at the promotion and preservation of public health, order, safety and general welfare of its inhabitants;

WHEREAS, the fourteen hospitals being operated by the Province of Pangasinan continuously generate healthcare wastes that require proper collection, treatment and disposal;

WHEREAS, the Clean Leaf International Corporation is a duly registered waste management company that provides environmental services through transport, treatment and disposal of hazardous and non-hazardous materials;

WHEREAS, the Clean Leaf International Corporation has offered its services to the Province of Pangasinan for the transport, treatment and disposal of the healthcare wastes of the provincial government hospitals at its Waste Treatment Facility located in Barangay Cutcut, Capas, Tarlac;

WHEREAS, the proper disposal of hazardous and non-hazardous wastes in the Province of Pangasinan is in support to the thrusts of the national government in addressing environmental concerns in compliance with RA 6969 or the Hazardous Waste Management Act, RA 9275 or the Clean Water Act, RA 9003 or Ecological Solid Waste Management Act and other environmental laws;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Agreement with the Clean Leaf International Corporation for the implementation of the healthcare waste management of the Province in order to protect the people and the surroundings of Pangasinan from the harmful effect of hazardous medical wastes;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Clean Leaf International Corporation, represented by represented by Atty. Emily G. Claveria, President of Clean Leaf International Corporation;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with Clean Leaf International Corporation for the implementation of healthcare wastes management of the fourteen (14) Provincial Government Hospitals of Pangasinan;
