RESOLUTION NO. 671-2022

DECLARING MUNICIPAL ORDINANCE NO. 5-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING THE COMPOUNDING, DISPENSING, SELLING OR RESELLING OF PHARMACEUTICAL PRODUCTS THROUGH RETAIL DRUG OUTLETS NOT LICENSED BY THE FOOD AND DRUG ADMINISTRATION (FDA) AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Municipal Ordinance No. 5-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (1) (iii) of R.A. No. 7160; R.A. No. 10918, entitled "An Act Regulating and Modernizing the Practice of Pharmacy in the Philippines, Repealing for the Purpose Republic Act Numbered Five Thousand Nine Hundred Twenty-One (R.A. No. 5921), otherwise known as the Pharmacy Law" and DILG Memorandum Circular No. 2022-025 to Provincial and Local Government Units which speaks of dispensing, selling and reselling of pharmaceutical products in sari-sari store;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 5-2022 of the Sangguniang Bayan of Urbiztondo, Pangasinan, entitled “An Ordinance prohibiting the compounding, dispensing, selling or reselling of pharmaceutical products through retail drug outlets not licensed by the Food and Drug Administration (FDA) and providing penalties for violation thereof” as within the conferred powers of the Sangguniang Bayan to enact;
