APPROVING AND ADOPTING AS ITS DECISION EN BANC, THE RESOLUTION OF THE COMMITTEE ON GOOD GOVERNMENT AND ACCOUNTABILITY OF PUBLIC OFFICERS, JUSTICE AND HUMAN RIGHTS IN SP ADMINISTRATIVE CASE NO. 06-2020

WHEREAS, the Sangguniang Panlalawigan is in receipt of an Administrative Complaint filed on September 14, 2020 by SB Members Armando C. Rivera and Noel I. Talania against SB Members Rolando C. Catabay, Philip O. Estabillo, Elmer N. Ocampo Amelia R. Olores, Warlie C. Dollaga and Mark Gringo B. Ampler of the Local Government Unit of Bani, Pangasinan;

WHEREAS, the said case was referred to the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights and was docketed as SP Administrative Case No. 06-2020 by 10th Sangguniang Panlalawigan;

WHEREAS, the Committee on Good Government and Accountability of Public Officers, Justice and Human Rights conducted several hearings on the above administrative case;

WHEREAS, on the February 28, 2022, the Committee issued an Omnibus Order archiving all the pending administrative cases due to the May 9, 2022 National Elections;

WHEREAS, after the May 9, 2022 elections, the Committee submitted its Resolution which was adopted as Committee Report No. 06-2022 by the 11th Sangguniang Panlalawigan, to wit:
