PROVINCIAL RESOLUTION NO. 675-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PANGASINAN STATE UNIVERSITY, REPRESENTED BY DR. DEXTER R. BUTED, AS PARTNERS FOR COOPERATION IN THE IMPLEMENTATION OF ACADEMIC, RESEARCH, EXTENSION AND SPORTS DEVELOPMENT PROGRAMS

WHEREAS, the provincial government has been determined in defining its role to help local government units and other institutions in the application of policies, programs and projects aimed towards the development and improvement of services for the constituencies of the Province;

WHEREAS, the Pangasinan State University, a premier state university in the Province with an estimated total number of 37,500 students for School Year 2022-2023, intends to establish a partnership cooperation in the implementation of its academic, research, extension and sports development programs with the Province of Pangasinan;

WHEREAS, the Memorandum of Understanding is necessary for the Province of Pangasinan and the Pangasinan State University to identify the specific terms required in the agreement;

WHEREAS, one of the salient features of the agreement is the use of facilities of the Provincial Government particularly the Narciso Ramos Sports and Civic Center by the Pangasinan State University in order to enhance the sports development program of both parties;

WHEREAS, the Memorandum of Understanding will serve as a vehicle for collaborative efforts between the Province of Pangasinan and the PSU for the implementation of related activities for the program;

Guico III, to enter into Memorandum of Understanding with the Pangasinan State University, represented by Dr. Dexter R. Buted, as partners for cooperation in the implementation of academic, research, extension and sports development programs;
