## PROVINCIAL RESOLUTION NO. 679-2022

INVITING THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE, THE PROVINCIAL BUDGET OFFICE AND OTHER CONCERNED OFFICIALS OF THE PROVINCE TO SANGGUNIANG **OF** THE QUESTION HOUR PANLALAWIGAN TO BRIEF THE BODY ON THE CURRENT STATUS OF THE SECTORAL RESOURCE CENTER LOCATED IN LINGAYEN, PANGASINAN IN ORDER TO EXPLORE AREAS CONCERNED **AMONG** THE COOPERATION DEPARTMENTS AND THE SANGGUNIANG PANLALAWIGAN ON HOW THE SAID CENTER MAY COMMENCE OPERATION AT THE SOONEST TIME

WHEREAS, it is a policy of the State under the 1987 Constitution of the Philippines to protect Persons with Disabilities (PWD) and promote their welfare and development and Republic Act No. 7277, otherwise known as the Magna Carta for the Disabled Persons, also affirms, confirms and mandates rehabilitation, self-development and self-reliance, and integration of Persons with Disabilities into the mainstream society;

WHEREAS, the Provincial Government of Pangasinan has recently completed the construction of the Sectoral Resource Center of the Provincial Social Welfare and Development Office in Lingayen, Pangasinan, of which the center was supposed to provide service and support to those suffering from optical and hearing difficulties commonly seen among our elderlies, evaluation and support for victims of violence against women, assessment and support for parents of Children with Disabilities, to name a few;

WHEREAS, that while significant part of the project has already been addressed, the Sangguniang Panlalawigan has been informed that the center has not been able to become fully operational due to several issues;

WHEREAS, the Members of the Sangguniang Panlalawigan share the sense that in light of the worthy objectives to which the Sectoral Resource Center was established for, it will be beneficial for the province in general, and for the underserved but equally important sectors in particular, for the Provincial Government of Pangasinan to move in and explore options to ensure that resources are coursed toward this end of operating the center at the soonest time;

**NOW THEREFORE**, in view of the foregoing premises, on motion by SP Member Jerry Agerico B. Rosario and SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was-

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to invite, as they are hereby invited, the Provincial Social Welfare and Development Office, the Provincial Budget Office and other concerned agencies of the Province to a Question Hour of the Sangguniang Panlalawigan to brief the Body on the status of the Sectoral Resource Center and explore areas of cooperation to facilitate its start of operation at the soonest possible time;
